Southern Minnesota Initiative Foundation Paint the Town Grant Program Guidelines and Procedures

Effective January 2018

Southern Minnesota Initiative Foundation (SMIF) is a catalyst for economic growth in 20 Minnesota counties. We work to build a prosperous region with vibrant communities and innovative businesses. To accomplish this, we invest in early childhood, economic development and community vitality initiatives.

SMIF's Paint the Town Grant Program is designed to engage volunteers and build collaborative efforts that beautify communities with a population under 10,000.

Through Southern Minnesota Initiative Foundation (SMIF), IRS-Designated 501(c)(3) nonprofit organizations and units/agencies of local, state and federal government in southern Minnesota can apply to receive free paint products for Community Mural, Community Welcome Sign or Historic Structure projects. The Paint the Town Grant Program is administered by SMIF in partnership with 11 Ace Hardware stores. The participating stores are located in Chaska, Faribault, Mankato, Northfield, Owatonna, Rochester (3 locations), Shakopee, St. Charles, and St. Peter. SMIF generously donates the paint products.

Up to ten applicants will be chosen from this grant round for a Community Mural, Community Welcome Sign or Historic Structure project and the award will be announced May 31, 2018.

Funding

Between 15-100 gallons of paint from selected Ace Hardware stores valued around \$25 per gallon.

Eligibility

To be eligible for a SMIF grant, organizations must meet the following requirements:

- Eligible organizations are tax exempt 501(c)(3) organizations, units/agencies of local, state or federal government and public schools/higher education institutions.
- Located (or serve) within SMIF's 20-county region:

- Community population must be under 10,000 (U.S. 2010 Census)
- All projects must exhibit visual impact, current/intended public use of the structure, and volunteer participation.
- Privately-owned buildings must have a government organization or IRS designated 501(c)(3) nonprofit organization as a fiscal agent to receive the paint.
- Historic structures must be owned and operated by a government organization or IRS designated 501(c)(3) nonprofit organization.
- At least 50% of the painting must be done by volunteers.
- Muralists/artists who assist in the design and application are acceptable.
- Paint requests must be between 15-100 gallons. SMIF reserves the right to limit paint product amounts awarded.
- SMIF only covers the cost of awarded paint; grantee is responsible for the cost of supplies, equipment and any additional paint.
- Only Community Mural, Community Welcome Sign or Historic Structure projects will be considered.

Exclusions

Ineligible organizations or activities include:

- Organizations that do not meet the above criteria
- Privately-owned facilities that require membership/fee for access

APPLICATION PROCESS

Grant Review and Award Process

SMIF awards paint grants on a competitive basis.

A review committee created by SMIF will make the final grant award decisions.

Grant recipients are required to connect with a representative of one of the participating Ace Hardware stores to discuss the details of their project and order paint products. The store contact information will be provided with award letter. The store will invoice SMIF for the cost of the awarded paint.

Grant recipients must pick up their paint products at one of the participating Ace Hardware stores. Please consider travel costs before completing the application.

The Project Completion Report and photos of the completed project must be provided to SMIF no later than December 3, 2018.

SMIF will issue a press release highlighting the recipient and their project.
